Madison added **4 more** new listings to the market than it took off (put under contract), **which increased the overall supply**. Home sales (*closings*) **increased** in January, just remember that many of those homes went under contract in a *previous* month.

The *total* number of active listings **increased 1%** compared to December, 50% of homes went under contract in **52-days** *or less*, and at this rate there's about **5.2-months of supply** to go around.

The average price of a home in Madison County was \$22k more than it was this time last January. On average, properties sold for 94% of their list price at the time the offer was made, and 91% of the price they originally listed for.

#### **Learn the lingo**

**Active Listings:** This is the total number of listings that were for sale *at any given point during the month.* 

**Under Contract:** This is the total **number** of listings that accepted an offer to purchase *during the month*.

**Under Contract (%):** This is the "Under Contract" column represented as a **percentage** of the county.

Pending Ratio: This ratio is calculated using a snapshot taken at 11:59pm on the last day of the month. It used to show a price range's competitiveness by comparing the number of listings under contract to the total number of listings on the market at the time the snapshot was taken (active + under contract).

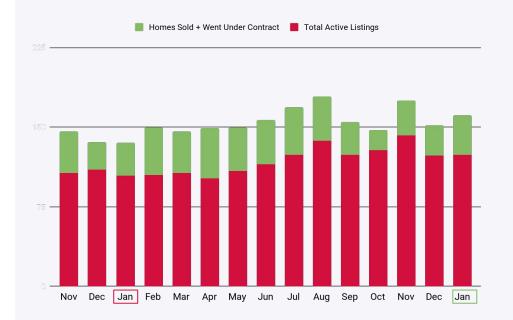
Months of inventory represents how long it would take to deplete the current inventory assuming no new homes are put on the market. It's commonly used to determine the health of a particular market.

Between 0-4 months of inventory is considered a seller's market because supply is relatively low, which means that sellers have more control to set terms or raise prices. 5-7 months signals a balanced market there is a healthy mix of buyers and sellers. 8 or more months of inventory indicates a buyer's market, which means buyers have more negotiating power.

Buyer's Market

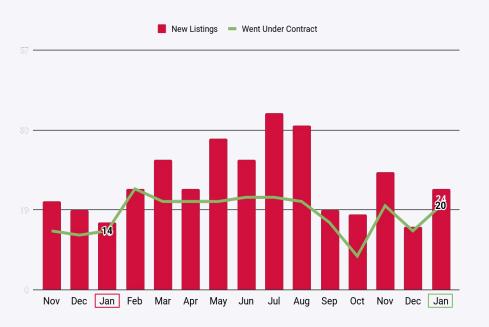
# Volume & Activity



- → The number of active listings increased by 1% in January. Total Active listings, the number of properties listed for sale at any point during the month, was up 19% compared to last year.
- → Total homes under contract increased 43% from last month, and Madison had 43% more homes under contract in January than it did this time last year.
- → Overall volume was up 3% from last month and up 10% from this time last year.

# Listings & Pendings

- → New listings increased 60% from last month, and were up 50% from last January's numbers.
- → 43% more homes went under contract, and Madison had more homes going under contract than this month last year, up 43%.
- → Pro Tip: keeping an eye on the difference between homes added to the market (new listings) and those taken off (by going under contract) is the best way to gauge supply & demand!



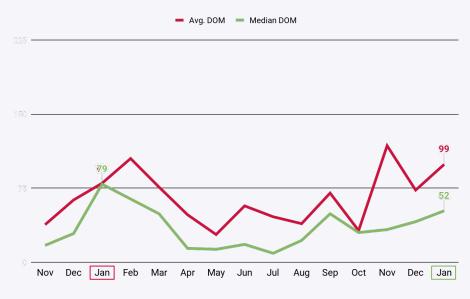
### **Home Prices**



- → The average home price in Madison County increased 2%, and homes were valued 4% higher compared to last January.
- → The positive home value appreciation trend seems to be holding despite interest rates.
  Pro Tip: monthly price fluctuations are less indicative than annual trends for understanding market shifts!
- → The consistently higher average vs. median home price tells us that Madison's high-end market is strong, with prices significantly higher than the rest of the market.

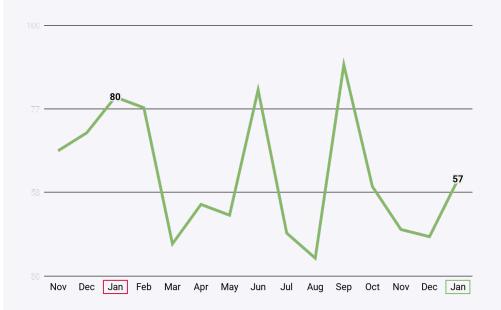
## Days On Market

- → On average, homes took 26-days longer to go under contract than they did in December, and the median days it took to sign a purchase contract was 52-days (!!!).
- → Homes between \$250-299k sold fastest in January, with a median 3-days on the market, followed by homes in the \$500-599k range, which took a median of 6-days.
- → Homes in Madison are selling quickly due to a combination of extremely low inventory and high demand for homes.



The median DOM is the "middle DOM," meaning half of the homes during the month went UC faster and half took longer than the median. The average DOM is the total DOM divided by number of sales.

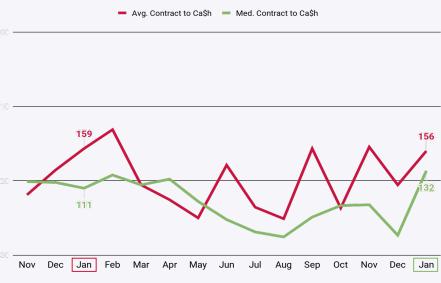
## **Contract To Close**



- → Contract to close time took an average of 16-days more compared to last month, which was 23-days faster compared to last January.
- → Homes valued valued between \$1M-1.49M took among the longest to close. January closings data put that segment at around 238-days, on average.
- → Homes valued valued between \$350k-399k closed fastest, closing in ~10-days, on average.

## Contract To Ca\$h

- → Sellers got paid an average of 41-days slower after listing their homes according to January sales data, but 3-days faster than Jan., 2023.
- → This overall increase was a due to increases in both time spent during the contract to close process as well as time spent on the market (DOM).
- → Homes valued valued between \$500k-599k sold fastest, averaging 37-days, followed by the valued between \$250k-299k price range which took 44-days, on average.



The median Contract to Ca\$h is the "middle number," meaning half of the homes that closed during the month got paid faster faster and half took longer than the median. The average Contract to Ca\$h is the total time it took across all price ranges divided by number of sales.

# Methodology

Data for this report was pulled from Canopy MLS for Single Family and Condo/Townhouse properties on February 3rd, 2025. Realtors are required to update their transactions on the MLS within 48hrs, so while most records for the month should have been accounted for, any updates that occured after the report was pulled will not have made the cut. This should not have a material effect on the data given the overall volume of transactions.
