AMENDMENT AND ADDENDUM TO COVENANTS AND RESTRICTIONS FOR CUMMINGS COVE

This Addendum and Amendment to Covenants and Restrictions for Cummings Cove and Amendment and Addendum to the Landscape and Reservation of View Easement is made and entered into in Hendersonville, Henderson County, North Carolina by and between Cummings Cove Company, L.L.C., a Florida Limited Liability Company, hereinafter referred to as "CCC," and Cummings Cove Investment, LLC, a North Carolina Limited Liability Company, hereinafter referred to as "CCI" on this 4th day of January, 2017.

WITNESSETH

WHEREAS, CCC and CCI own all of the unsold and/or undeveloped real property in Cummings Cove Golf and County Club by virtue of deeds recorded in Deed Book 1211 at Page 173, in Deed Book 954 at Page 369 and in Deed Book 963 at Page 345, all of the records of the Registry for Henderson County, North Carolina; and

WHEREAS, that property known generally as Cummings Cove was subjected to Covenants and Restrictions on May 7, 1985 recorded in Deed Book 658 at Page 44, Henderson County Registry, which covenants were supplemented by instrument recorded in Deed Book 723 at Page 767, Henderson County Registry, and Restatement and Amendment recorded in Deed Book 1036 at Page 499, Henderson County Registry, restated in that Restatement and Amendment to Covenants and Restrictions dated May 12, 2009 and recorded in Deed Book 1385 at Page 171, and to Restatement and

WHEREAS, CCI and CCC now desire to add the provisions of the Landscape and Reservation of a View Easement to the remaining unsold and undeveloped properties in the Mountain Top Section of Cummings Cove and to the additional phases of Mountain Top that will hereafter be recorded and filed in the Registry for Henderson County, North Carolina, with said additional phases currently being shown on the Master Plan of Cummings Cove Golf and Country Club by Civil Design Concepts, PA, which Master Plan now is found in the office of Cummings Cove Golf and Country Club in Henderson County, North Carolina; and

WHEREAS, the previously sold lots in the Mountain Top Section of Cummings Cove have also been transferred subject to the provisions of the Reservation of a View Easement; and

WHEREAS, CCI and CCC intend to develop the remaining phases in Mountain Top in Cummings Cove Golf and Country Club according to the Master Plan and desire to subject the remaining unsold developed properties and undeveloped properties in the Mountain Top Sections of Cummings Cove to the terms and provisions of the Landscape and Reservation of a View Easement recorded in Deed Book 1241 at Page 674 of the Registry for Henderson County, North Carolina, and this document shall provide notice to any future purchasers of undeveloped properties or developed lots within Mountain Top Subdivision that have not yet been sold to the provisions of the Landscape and Reservation of a View Easement document recorded in Deed Book 1241 at Page 674; and
