This AMENDMENT TO COVENANTS AND RESTRICTIONS FOR CUMMINGS COVE is made this ______ of September, 2018, by CUMMINGS COVE Company, LLC, a Florida Limited Liability Company, hereinafter called "Developer."

AMENDMENT TO ARTICLE I

Article I shall be amended by adding Peragraph 1.19.1 as follows:

1.19.1 Temporary Rental shall mean occupation of a Dwelling Unit by a non-Owner in exchange for rent or any other value.

AMENDMENT TO ARTICLE IX

Paragraph 9.15 shall be added as follows:

- 9.15 Restrictions on Temporary Rentals.
 - 9.15.1 Minimum Rental Period. The minimum rental period allowed for a Temporary Rental is one (1) month. Shorter term Temporary Rentals are allowed only in order to facilitate the transfer of a Dwelling Unit (i.e. before/after closing the sale of a Dwelling Unit).
 - 9.15.2 Maximum Number of Rentals Per Year. A Dwelling Unit in Cummings Cove shall not be used for or as a Temporary Rental more than five (5) times during any calendar year.
