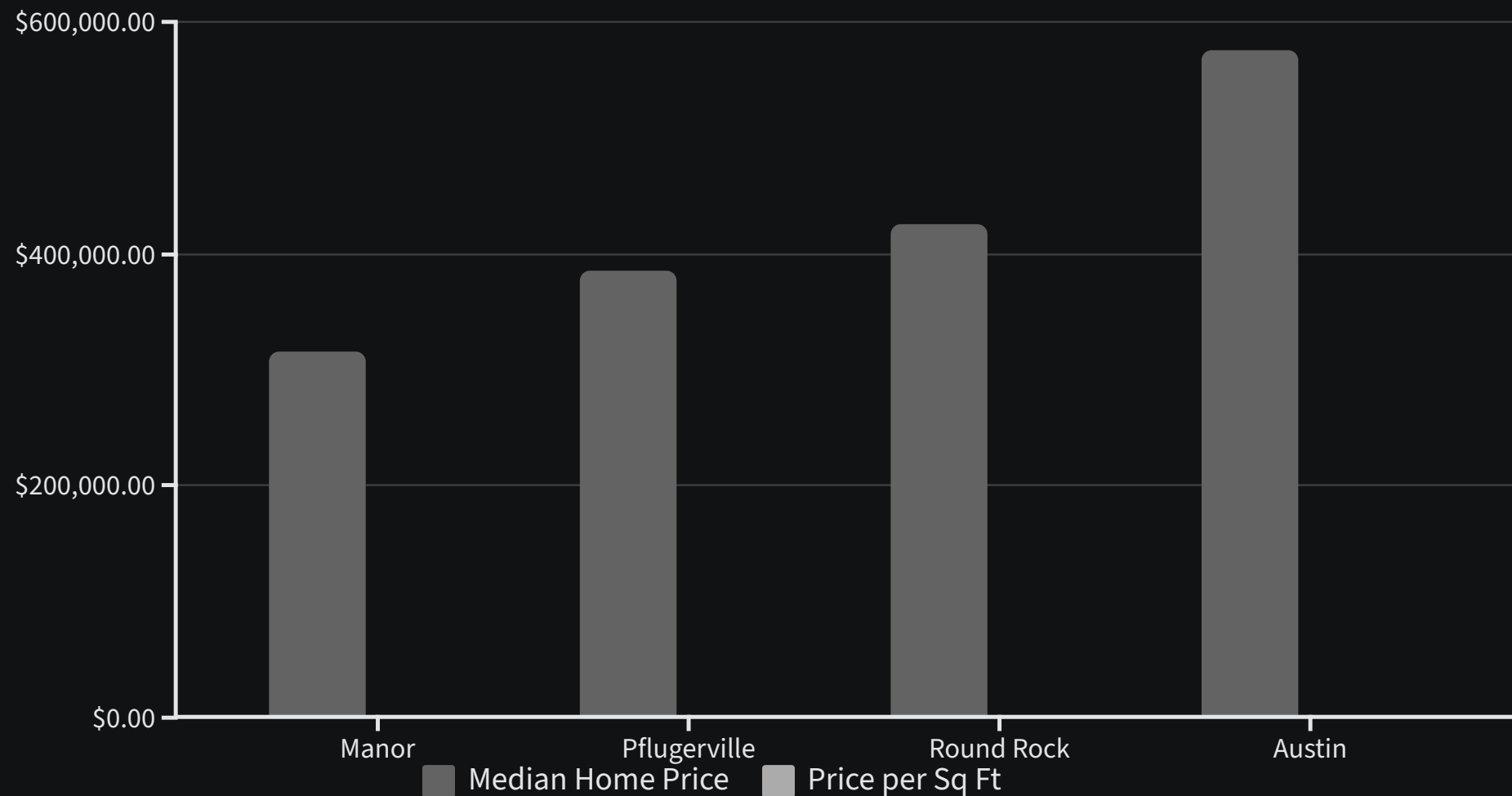

Housing Market Analysis: What to Expect

Manor's housing market offers exceptional value compared to Austin and other nearby cities. The median home price in Manor is approximately \$315,000, significantly lower than Austin's median of \$575,000. 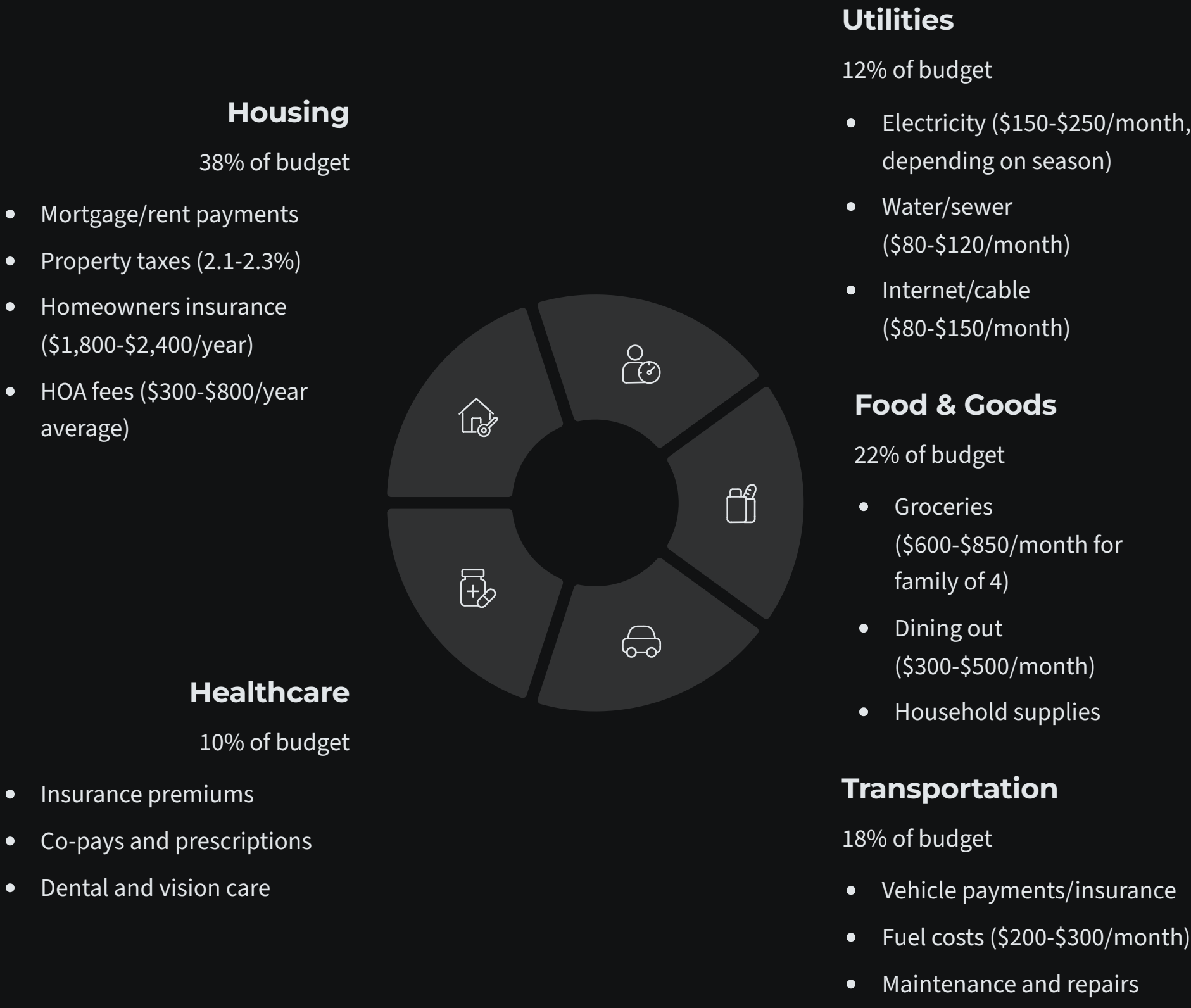

Limited Local Amenities & Retail

Manor's commercial development is still catching up to residential growth. While basic services exist, residents often travel to Pflugerville, Round Rock, or Austin for major shopping, dining variety, entertainment, and specialized services. Commute Times During Peak Hours

School District Still Developing

Limited Public Transportation
